## **Mission Statement**

Executive Security International, Ltd. exists to raise the standard in Executive Protection, PSD Protective Operations, Corporate Security Management and Tactical Medicine through intelligence-based training.

## **History**

In 1980, after a decade as a director of the Aspen Academy of Martial Arts and protection work for celebrities, Bob Duggan created training programs under the egis of Executive Security International, Ltd (ESI). In 1981, ESI was founded as a closely held Colorado Corporation, and the school was approved and regulated by the Colorado Department of Higher Education under the Private Occupational Education Act to offer a 600-hour combined Distance Education and Resident Training Program. In 2012, ESI's home delivery Distance Education courses were taken ON-LINE.

In 1989, ESI received approval for its Intelligence and Investigation Program, which was further expanded in 1996 to become the highly regarded Protective Intelligence Program. In 2005, ESI introduced a series of 28-Day Residency Programs that included Executive Protection and PSD Protective Operations. The 28-Day Tactical 1st Responder Medical and the Corporate Crisis Management Programs followed soon afterwards. The Residencies cover the theory and practical training components in full time format where students complete all of the training in classroom or practical field training. In 2011, ESI's four week Tactical 1st Responder Medical Program was approved.

In 2012, Bob Duggan created a new educational platform, The International Security Institute, (ISI) for a broad curriculum in the many facets of corporate security and threat management. The International Security Institute is a wholly owned sub-division of ESI.

Conducting training since 1980, ESI is an intelligence based Executive Protection, and Corporate Security Training Academy that offers 2000 hours of peer reviewed curriculum from which the student can choose to suit their career goals.

## **ACADEMIC STANDARDS ESI CERTIFICATES AND CREDENTIALS**

ESI offers a number of Certificate and Credential Programs. The student may select either a full time resident classroom instruction format or the combined On-line Education/15 Day Resident Training version, which permits the student to enter into an independent study of correspondent courses that are completed on-line and then attend

15-Day Resident Training in Executive Protection. The Residency Program is a classroom-practical training that is made up of four Modules: 28-Day Executive Protection, 28-Day PSD Protective Operations, 28-Day Corporate Security Management, 21-Day Designated Defensive Marksmanship. The Modules can be taken sequentially or separately.

ESI offers to graduates of all State of Colorado Department of Private Occupational Schools approved programs a Certificate of Completion for completing either format of the Residency Modules or one of the combined On-line Education/ Resident Training programs. The ESI Identification Credential is not required by the State of Colorado Department of Private Occupational Schools, but is well known and respected in the security industry as the standard for academic and practical training in high risk, executive protection, protective intelligence and Corporate Security.

ESI's Combined On-line Education/Resident Training Certificate and Credential Programs: Executive Protection Program and Security Specialist Program -- offer flexible formats. Each requires a core of five specialized On-line Education courses, and, depending on the program, four to thirteen elective On-line Education courses, as well as a Resident Training component. Thus, the student has the opportunity to customize his or her training according to their needs.

### **CERTIFICATES OF COMPLETION**

A Certificate of Completion is awarded for all Certificates programs as well as Continuing Education courses for fulfilling the requirement of each Program or course. The Certificate has no Grade Point Average requirement.

## **THE ESI CREDENTIAL**

### **CERTIFIED EXECUTIVE PROTECTION & SECURITY SPECIALIST PROGRAMS**

ESI awards an ESI Identification Credential for completion of any Core Program whether On-line Ed/Resident Training or full time Residency with a Grade Point Average of 80% or above. Completion of the Residency Program with less than 80% will be awarded a Certificate of Completion. Completion of lessons with a 90% GPA will be awarded "With Honors" designation on the Credential.

### **CERTIFIED SECURITY SPECIALIST, CSS**

CSS Identification Credential has two formats:

The CSS is awarded for completing 18 On-line Education Courses containing 108 lessons and 15 Days of Resident Training in Executive Protection with an accumulative Grade Point Average of 80%. Completion of the program with less than 80% will be awarded a Certificate of Completion. A GPA of 90% is awarded a CSS Credential with Honors.

Alternatively, the CSS Credential can be attained by completing classroom and practical exercises in two 28-Day Residencies with a GPA of 80% or above. A GPA of 90% is awarded a CSS Credential with Honors. The two Residency Core Programs are, Executive Protection and Corporate Security Management.

### **CERTIFIED PROTECTION SPECIALIST, CPS™**

CPS™ Identification Credential is attained by completion of 600 Clock Hours of lessons consisting of nine On-line Education courses containing 54 Lessons, and 15 Days in Resident Training or 28-Days of classroom and practical exercises in the Executive Protection Residency Program with a combined Grade Point Average of 80% or above. Completion of the program with less than 80% will be awarded a Certificate of Completion. While there is no time limit placed upon completion of lessons in On-line Ed curriculum, after nine months no refunds will be due. There is no extra cost associated with completing the Credential Program.

### **CORPORATE SECURITY MANAGEMENT, CCMS**

CCMS Identification Credential is attained by completion of the 28-Day of classroom and practical exercises in the Corporate Crisis Management Program with a total Grade Point Average of 80% or above. Completion of the program with less than 80% will be

awarded a Certificate of Completion. The Corporate Crisis Management Program is only offered in Residency format. There is no extra cost associated with completing the Credential Program.

**CERTIFIED PSD PROTECTIVE OPERATIONS SPECIALIST, CPSOS**  
CPSOS Identification Credential is attained by completion of 28-Days of classroom and practical exercises in the PSD Protective Operations Residency Program with a combined Grade Point Average of 80% or above. Completion of the program with less than 80% will be awarded a Certificate of Completion. There is no extra cost associated with completing the Credential Program.

**CERTIFIED DESIGNATED DEFENSIVE MARKSMANSHIP SPECIALIST, CDDMS**  
CDDMS Identification Credential is attained by completion of 21-Days of classroom and practical exercises in the Designated Defensive Marksmanship Program with a combined Grade Point Average of 80% or above. Completion of the program with less than 80% will be awarded a Certificate of Completion. There is no extra cost associated with completing the Credential Program.

## **ADMINISTRATIVE PROCEDURES**

### **ENTRANCE REQUIREMENTS**

The school does not discriminate based on race, sex, religion, ethnic origin, or disability.

Prospective students must have a high school diploma or equivalency diploma to be accepted for enrollment.

### **ENROLLMENT**

Prospective students may enroll anytime. Late enrollments will be accepted only one day into the course, depending on length of the course.

### **POSTPONEMENT OF START DATE**

Postponement of a starting date, whether at the request of the school or the student, requires a written agreement signed by the student and the school. The agreement must set forth:

- a. Whether the postponement is for the convenience of the school or the student, and;
- b. A deadline for the new start date, beyond which the start date will not be postponed.

If the course is not commenced, or the student fails to attend by the new start date set forth in the agreement, the student will be entitled to an appropriate refund of prepaid tuition and fees within 30 days of the deadline of the new start date set forth in the agreement, determined in accordance with the school's refund policy and all applicable laws and rules concerning the Private Occupational Education Act of 1981.

## **STANDARDS OF ACADEMIC PROGRESS**

### **GRADE POINT AVERAGE**

GPA in Residency Program is derived by accumulative scores of open book lesson tests, special written team and individual assignments and practical skills testing from each course and averaged for a grade in the Module. The GPA of the three Modules are averaged to attain the Certified Security Specialist Credential.

The GPA for the combined On-line Ed/Resident Training is derived by combining On-line Education (value 40%) and Resident Training (value 60%). If a student scores under 80% in any Resident Training class, a re-examination can be scheduled for a later date. Instructors will grade students on performance and adherence to ESI standards of safety and conduct. Each

student is given an evaluation of his test scores at the completion of the program. In return, students are asked to evaluate instructors and classes.

### **GRADING SYSTEM**

All Residency Program courses are graded by open book lesson/test method for each course within a Module of the program. Special written Team and Individual assignments are required in some courses. The Certificate of Completion students need only pass the course within a Module with a Pass or Fail Grade with failure calculated at 70% or less. Each course undertaken within each Module will be included in the computing of the GPA. A GPA minimum of 71% will be required at the end of each Module to enter the second and third Module. If the student scores 70% or less in any course, a re-examination can be scheduled for a later date. If the student drops below 60% in the first half of the program, he or she will be terminated from the training. If the student achieves a cumulative GPA of 80% or better in each Module, the student is awarded an ESI Credential, and a GPA of 90% is awarded an ESI Credential "With Honors".

On-line testing. The student will complete the online test and will receive a grade on the test immediately upon submission for grading. Certificate of Completion students need only pass the single lesson contained in each course with a Passing Grade. The ESI Certificate of Completion is awarded after completion of both On-line Education and Resident Training. Every student will be required to maintain a minimum composite On-line Education grade score of 60% to qualify for a Pass Grade. If the student scores under 70% in any course, a re-examination can be scheduled for a later date. If the student drops below 60% in the first half of the program, he or she will be terminated from the training.

The Identification Credential contains 54 Lessons in the Program and several courses require special assignments to be completed as part of the testing score. For students who pursue the Extra Credit, an ESI transcript of Grade Point Average is mailed to the student upon completion of all lessons, tests and special assignments.

During Resident Training, instructors administer either a written or practical test at the end of shooting, medical, protective detail operations, and stalking problem classes. Each student who scores a composite 80% or better in the practical examinations and who satisfactorily completes Residency Program or the On-line Education /Resident Training will be given an ESI Identification Credential as a qualified PSD PROTECTIVE OPERATIONS SPECIALIST, SECURITY SPECIALIST, PROTECTION SPECIALIST, or CORPORATE CRISIS MANAGEMENT SPECIALIST.

## **GRADING**

Certificate of Completion students are graded in On-line Education courses with open book Pass or Fail grade. Resident Training contains a number of Skill Based Tests.

Students who pursue the Identification Credential are graded by calculating Grade Point Average of both 54 and 108 Lessons of On-line Education and Resident Training. The grade for each course is found by counting the average of the lesson examination grades. Letter grades are converted to percentage points for the purpose of computing the Grade Point Average for each semester.

Grades are as follows:

Students who officially withdraw from a course are given a grade of I (Incomplete).

### **STUDENT HONORS**

Students who have maintained a Cumulative Grade Point Average of 3.5 (90%) or better and completed all other requirements for graduation will receive their Credential with honors.

### **CREDIT FOR PREVIOUS TRAINING**

The School may request that the applicant to take a proficiency test in a course the student desires to be given credit, and the minimum passing score is 77% or better. A lower score will mean that the student will not receive academic credit for the course. Granting of credit for academic or work experience does not impact stated Refund Policy.

ESI is approved by the Colorado Office of Veterans Education and Training  
(COVET) for Veterans Education and Training Benefits.

### **SPECIAL CREDIT FOR MILITARY VETERANS:**

Credit for Previous Education and Training Acceptance Policy. Executive Security International, Ltd. (ESI) will evaluate previous education and training and when applicable credit will be given.

### **CONTINUING EDUCATION**

ESI's On-line Education courses are approved and regulated by the State of Colorado Division of Private Occupational Schools Board.

### **RECORDS AND TRANSFER OF CREDIT**

Permanent records of grades and scores are maintained on school premises and copies are available for a nominal fee. Credit given by other post-secondary institutions for training completed at Executive Security International is at the discretion of each institution, which has the privilege of extending or withholding transfer credit, based on their educational standards and curriculum.

The school does not guarantee the transferability of its credits to any other institution unless there is a written agreement with another institution.

### **ONLINE EDUCATION-RESIDENT TRAINING**

The nine On-line Education Courses in the Executive Protection Program must be completed in nine months, or eighteen months for the Security Specialist Program after which time the student will not be entitled to a refund. All Residency Programs are conducted entirely in classroom settings at ESI's training facility in a 28/15-Day format. Whether the student completes a Core Program in combined On-line Ed-Resident Training or full time Residency, the Certificates and Credentials are equivalent. Further, applicant understands that Tuition does not cover additional required books, food, lodging, or gun rental during Resident Training or transportation to the training sites. In Residency classroom instruction requires attendance of 96% or 26 days of the 28-Day Executive Protection, PSD Protective Operations and Corporate Crisis Management.

Non completion of On-line Education courses for thirty days without official Withdrawal will determine the point at which the student ceases to make satisfactory progress and will be placed on academic probation for twelve months. If no further progress is made, the student will be terminated from the program. A terminated or cancelled student is eligible for Tuition Refund stated below or re-enrollment with full credit for tuition paid and academic grade.

### **GENERAL INFORMATION**

All information regarding Admissions, Withdrawal, Termination, and Refund Policy is identical with ESI's Certificate Programs.

### **ACCREDITATION AND AUTHORIZATION**

Executive Security International, Ltd. (ESI) is a state approved academy for approved Certificate

Programs of combined Resident Training and Distance Education by correspondence as well as full time Residency study. ESI is approved and regulated by the Colorado Department of Higher Education, Private Occupational School Board.

### **RE-ENROLLMENT**

Students who cancel or terminate a Certificate Program may re-enroll with full credit for tuition paid towards their chosen program and for academic courses completed for a period of five years. After six years, ESI is not obligated to preserve records and may not be able to validate claims of tuition paid and lessons completed. In such cases, the administration will make a good faith effort to reconstitute records but cannot guarantee success.

## **STANDARDS OF CONDUCT**

ESI reserves the right to terminate a student's enrollment in On-line Education program for any of the following reasons:

1. Falsifying information.
2. Cheating.
3. Failing the final examination.
4. Failure to maintain minimum academic progress.
5. Failure to complete the program.

## **RESIDENCY PROGRAM**

### **SUSPENSION, TERMINATION AND INCOMPLETE GRADES**

The Residency Program requires attendance of every day of classroom instruction. A student is suspended from the program after three days of absence from classroom instruction during any Module. The student may officially Withdraw from a Module course with a grade of Incomplete for twelve months before the Incomplete is converted into Zero Credit for the course. Zero (0) Grade will be averaged with completed courses in order calculate GPA for a Module.

## **STUDENT PEER REVIEW CODE OF CONDUCT**

The Peer Review Code of Conduct was developed by students and administration. In 2011, this committee resolved that the award of a Certificate of Completion and the ESI Credential is conditional based completion of the program and tests performance, as well as observation of the following Code of Conduct:

1. Computers are required tools at ESI, and their use in class is for the purpose of class related research and following of lecture notes. Personal use of Facebook and other unrelated Internet browsing is grounds for dismissal from the class.
2. Personal Texting during class is prohibited. Time for texting is provided for during breaks.
3. Daily attendance in all sessions is required. Failure to have a legitimate excuse can result in disciplinary action, including termination from the program.
4. Repeated tardiness to class is subject to disciplinary action.
5. All students are required to participate fully in Team activity.
6. With the approval of Administration, Teams have the authority to fire or dismiss a delinquent member from their team. This action could deny the student eligibility of the ESI Credential.
7. Cheating, copying or plagiarizing of another Teammate's work can result in drastic reduction of grade for both parties.
8. Being disrespectful towards staff or students constitutes grounds for expulsion.
9. Disruptive behavior is prohibited and grounds for disciplinary action, including expulsion.
10. ESI has a "Dress Code" and students are expected to wear the uniform as directed.
11. Students are required to follow directives given by staff and instructors.
12. Any behavior that embarrasses ESI constitutes grounds for expulsion from the school.

## **TUITION**

The Tuition is set forth in the Enrollment Form. ESI may alter the price of its programs at its discretion. The On-line/Resident Training Certificate program is divided into two phases; the student is encouraged to complete the academic phase before the next phase is begun. Due to class scheduling, this may not be possible. The school will allow students to attend Resident Training and complete On-line Education afterwards.

The student may cancel his/her enrollment at any point within the program, within any phase of the training by notifying in writing the ESI National Office in Grand Junction, Colorado of their decision to cancel.

ESI offers two types of financing: Private Financing by SALLIE MAE, a company that is Federally supported and deals directly with the student. ESI acts only as a referral source. ESI also offers a no-interest financing arrangement for payment of On-line Education courses as a last resort. However, this form of financing requires that courses are shipped to the students at the rate of payments. ## **REFUND POLICY FOR VETERANS ENROLLED IN RESIDENCY COURSES**

For Veterans who are eligible to pay for the tuition from VA Educational Benefit plans are protected by this Refund Agreement until the student has completed 100% of the training program.

A \$500 non-refundable surety deposit is required upon enrollment into one of the residency programs. The fee will be returned to the Veteran, when the school receives payment from the VA. If the Veteran decides to not attend the non-refundable surety deposit will be retained by the school. This deposit can be used toward a future class for the time period of 3 years, after which time a new deposit will required.

In the case of students after commencement of classes, the school will retain a percentage of tuition and fees, which is based on the percentage of contact hours attended, as described in the table below. The refund is based on the first date of recorded attendance.

The student may cancel this contract at any time prior to close of the third business day after signing the enrollment agreement.

The official date of termination for refund purposes is the last date of recorded attendance. All refunds will be made within 30 days from the date of termination.

The student will receive a full refund of tuition and fees paid if the school discontinues a course or program within a period of time a student could have reasonably completed it, except that this provision shall not apply in the event the school ceases operation.

Complaints, which cannot be resolved by direct negotiation between the student and the school, may be filed with the Division of Private Occupational Schools. The Division shall not consider any claim that is filed more than two years after the date the student discontinues his/her training at the school.

### **REFUND POLICY - FOR STUDENTS ENROLLED IN COMBINED ON-LINE ED/RESIDENT TRAINING PROGRAM**

An applicant student requesting cancellation in whatever manner within this time must be given a refund of all money paid to the school or its representatives.

Students learn to operate as a team in order to detect surveillance while minimizing one's exposure.**

#### **Low Signature Protective Operations**

**This course is taught directly from the perspective that arms-length protection is not necessarily the best protection available. High Profile celebrities often want the sense of a security Shield that a visible protection agent can provide. His or her comfort zone is greater when there is someone capable of warding off unwanted attention. In corporate environments the presence of Protectors is usually**

**invisible. CEO's often don't want the intrusion into their personal space, but their Board of Directors mandate protective services.**

**The approach taken by our Low Signature Protective Operations is that Zero Presence is often more effective security than Arms-Length. The skills-sets are different, and the teaching philosophy focuses on the source of the threat rather than the principal.**

**Field drills include practical team maneuvers and assignments that emphasize the role of Proactive, Predictive, and Behavioral Intelligence as the basis for protecting the Principal. Focused on Low-Profile Clients, this course will prepare students to develop and implement exhaustive protection plans in a Corporate Environment.**

**The student is given a client itinerary and expected to determine a route destination, reasons for selection, and describe vulnerabilities. The Protective Detail is required to organize client itineraries and carry them out as a team. The teams are assigned to do advances for hotels, restaurants and the airport, produce a plan, give a presentation before ESI instructors, and then carry it out. These assignments are done in large and small protective details, on foot or in mobile convoys in an urban environment.**

**In the end, the individual student and the team must produce a Threat Assessment, a Management Plan and complete a FTX in the field. According to ESI's tradition of "Teaching to a Standard" there are consequences for failure.**

### **INTELLIGENCE-DRIVEN CORPORATE SECURITY & PROTECTIVE SERVICES**

#### **Overview of Course**

**This course is designed to allow risk mitigation professionals to develop and lead an intelligence-driven security and risk management role within a corporation or multinational organization. The course of instruction will stress functional knowledge of the intelligence, risk management and decision-making domains in a business application.**

#### **Risk Intelligence and The Intelligence Cycle**

**Students will learn the corporate applications of the intelligence cycle, standards of practice and code of conduct appropriate to modern enterprise. Students will learn how to use open sources of social media, methods and tools available, and what are the best practices for information management, report writing and circulation to upper management in a timely and useful format.**

**As an intelligence driven course, students will learn measurement principles and methods for risk management and protective operations. They will learn metrics and measurements challenges and how to identify risk priorities and communicate the results to management.**

#### **Crisis Management**

**This course will teach the state of practice of crisis management across corporate America, and how critical information and crisis is managed and communicated within the organization. The student will learn how issues of management converge with executive protection.**

**In addition to critical executive services, the student will learn the terms of major event security planning whether they are natural or human disasters; they will learn the key roles of operations planning and responsibilities. The course will cover managing critical organizational and external liaisons**

### **Intelligence and Corporate Protective Services**

**This course will cover program design for protective services and common management principles. Students will learn the PROTECTION MODEL for modern corporations as well as Adaptive vs. Protocol based protective operations.**

**This course covers executive protective services as a special category within corporate security. The student will learn how protective service practices have evolved in modern and multinational corporations in the information age. Students will learn how to manage information gathered on Groups or Persons of interest (GOI/POI).**

**Students will learn to distinguish between routine and extemporaneous activities and how to manage close protection in both environments. Incident Management is an integral component of protective services whether human or natural.**

**TECHNICAL SURVEILLANCE COUNTER MEASURES (TSCM) FOR PROTECTION  
AGENTS**

**Rich Roth, CTI Consulting**

**Overview of Course**

**Information Security is a critical aspect of corporate operations, whether it is Voice, Data or a mixture of both. Every corporate security professional needs to have a working understanding of the problem and how to develop solutions. The First priority is to understand the problem... we then need to keep the information safe and secure. Corporate security agents use these skills at corporate headquarters, and as a part of the Executive Protection Protocols for teams in the field.**

### **Risk Assessment of Technical Surveillance**

**This course will concentrate on teaching students how to conduct information Risk Assessments, as well as conduct basic Information Countermeasures. Basic TSCM skills will be taught using equipment staff can carry on assignments. Students will learn basic computer security countermeasures with software and available PCs.**

### **Covert Technical Surveillance Techniques**

**The course will cover basic covert surveillance techniques to give the student a working knowledge of issues they will be facing during the course. The legal aspects to both spying and countermeasures will be discussed to help ensure that the students understand their responsibilities and the legal pitfalls of counter espionage casework.**

**The course will cover the development of an espionage case from the point of view of the attacker and the methods used in developing their plan for acquiring the information they need. Each team in the course will be given an assignment of collecting information that is required from the victim for a successful attack. They will learn to utilize the extraction techniques in the most efficient ways to obtain the necessary information.**

**The instructors will teach the various technical means of gathering the information to include case studies of corporate espionage attempts and successes. Students will learn which equipment is the most applicable for the given assignment.**

### **Sweep Equipment**

**Students will learn how to select instruments for a Go-Bag of espionage equipment**

and how the instruments are used to conduct a basic counter espionage sweep of executive suites and meeting sites. The same scenarios will be used to show the students both the capabilities and limitations of counter espionage equipment.

### **Hacking Threat**

Students will learn how Hackers acquire information from unsecure computers and the best practices to secure personal and business computers. Students will learn cyber security methods while on the road with traveling executives and how best to defend their own systems in the process.

Students will learn all of the above in practical exercises with team and individual applications. They will graduate from this course with a basic understanding of how to conduct technical surveillance sweeps of physical spaces as well as computer equipment and the legal implications in a corporate environment.

### **PSD PROTECTIVE OPERATIONS PROGRAM**

The PSD Protective Operations course is focused on the basic concepts and building blocks of Protective Operations in a Combat Zone. Emphasis of training is live action exercises and team operations. The course will cover the following:

**Protective Operations**  
**Low Profile Protective Details in High Risk Zones**  
**Threat Assessment**  
**Personal Security Detail Operations**  
**Protective Intelligence**  
**Protective Shooting**  
**Special Protective Issues**  
**Performance Evaluation**

The course will begin with an overview of the requirements, duties and responsibilities of a Protection Agent in High Risk environments, including a summary of State Department Protocols for Presidential Security Details (PSD). From the understanding of the operational procedures of enemy tactics, the principles of protection simultaneously evolve and remain constant. Universal protective principles of Cover & Evacuate, Advances, Threat Assessment and Surveillance Detection are taught as constants, but adapting to the tactics of terrorists and the changing needs of the principal.

**Students learn the importance of route selection, accurate intelligence and analysis. Emphasis is placed is on methods and strategy to prevent attacks on the Principal or the Team. However, the student will become proficient in the skills necessary to defend against organized assaults, Attacks on Principal (AOP) Drills, Cover and Evacuation and apply AOP Drills in simulated urban ranges.**

**Lessons include:**

**The Threat, Types and Case Studies  
Principal Vulnerability Assessment  
The Protective Operational Plan  
Principal Briefing**

**This component of the training addresses the art of conducting Protective Advances for single-agent and multi-agent details. Pre-Departure Preparations, Site Surveys, Reports and Presentations will be discussed and demonstrated. Students will perform Advances in live urban environment and learn how the entire protective mission relies on the thoroughness of the Advance, accurate intelligence and pro-active measures.**

**Beginning with the Principles of Protection, the course covers a wide range of activities and operational skills required on a Protection Detail. Students learn via lecture and discussion, then reinforced learning via a series of practical exercises.**

**that allows the student to obtain a basic understanding of the critical role of surveillance detection in a hostile environment, and how to manage a covert counter surveillance operation.**

### **IMPROVISED EXPLOSIVE DEVICES**

**This course consists of a careful collection of documents from government agencies and private sources that analyze a wide variety of terrorist deployment of improvised explosive devices. ATF documents the application of VBIEDs and IEDs by Al Qaeda worldwide, their targets of attack and the means of delivery. The course discusses the widespread use of shaped charges and land mines by Al Qaeda and Insurgents in Iraq and Afghanistan that account for more than 50% of American troop fatalities. The course covers the use of suicide bombers, their motivations, recruitment and sacrificial suicide.**

### **BASIC CARBINE & HANDGUN**

**The Basic Carbine & Handgun course begins with an active inventory of shooting skills necessary to qualify with a carbine and handgun. The student must be a Level 1 graduate of ESI EP Shooting Course, recent Military or current Law Enforcement service.**

**The skill base will achieve the following:**

**Safety, Stripping, cleaning, assemble, function check of the weapon  
Fundamentals of marksmanship (Primary & secondary weapons)  
Weapon presentation drills (Primary & secondary weapons)  
Load / unload drills (Primary & secondary weapons)  
Administrative, tactical and speed reload drills (Primary & secondary weapons)  
Weapon malfunction drills  
Weapon transition drill and Combat speed shooting  
Single / multiple shots and targets  
Target identification drills  
Stationary turns  
Shooting on the move and Lateral shooting  
Firing positions (kneeling, prone, squatting)  
Barricade shooting  
Strong / weak hand drills  
Night shooting  
Two man / four- man team tactics**

**At the end of the Basic course there is a Staff evaluation of student's basic gun safety and weapon handling for primary & secondary tactics. The student must pass the Staff personal evaluation to qualify to enter the Tactical course. If the student fails to pass the minimum shooting qualifications and staff evaluation, he will be awarded a Certificate of Completion. The student will have the option of returning for remedial training or terminate the Program.**

#### **TACTICAL CARBINE AND HANDGUN**

**The Tactical Carbine & Handgun course builds on the basics and quickly moves on to higher skill sets. This course will stress the critical importance of immediate and aggressive reaction to assaults or ambushes. Teams will perform Immediate Action Drills (IAD) repeatedly until a coherent response of each team member can be predicted in actual convoy ambushes or protective formations. Once the student is able to demonstrate safe and accurate carbine fire in the basic building blocks of the Course of Fire, the student will advance towards tactical maneuvers**

**in Vehicle Convoys, Assaults on Formations and Assault of Principle, Multiple Threat Response and tactical awareness skills. The IAD drills will focus on reaction to 360 degrees of assault, shooting positions, clearing of the weapon stoppages, re-engagement, accuracy under stress and movement. Students who complete academic and practical components of the PSD Protective Operations Program will be awarded a Certificate of Completion and an ESI PSD Protective Operations Credential.**

**The Tactical Shooting course includes:**

Shooting from in / around Vehicles  
Initiative Based tactics (IBT)  
Advanced Room Clearing  
Advance Mission Planning  
Ballistic Breaching / Mechanical Breaching

Suicide Car Bombs Moving target engagement  
Target Indication / Identification  
Barrier / Medium shooting**

**This final block of instruction is a simulated terrorist assault on convoy with pyro-techniques. Student teams are expected to respond to the assault and protect assets. The course will stress firing from moving vehicle, target engagement and response to convoy ambush.**

**Given recent urban assaults on innocent civilian populations, this course will offer support to Law Enforcement marksmen.**

**Civilians with no criminal record are eligible to enroll in this long-range marksman's program. \***

**DDMs support protective security operations by gathering real-time intelligence information along routes, chokepoints, and at venue locations and provide over-watch protection of the PSD during walking formations and special events. DDMs assist in the preparation of security arrangements at venue locations; provide counter-surveillance and counter-sniper support, and prevent and deter attacks on the PSD by proactively identifying and interdicting potential threats through the delivery of long-range precision rifle fire and strict application of approved use of force policy.**

**This is an intensive and highly interactive course that uses various training sites, equipment, and “live-fire” training activities to replicate actual operational environments to facilitate an effective and realistic learning experience.**

**The program is directed by former Special Forces Sniper and Sniper Instructor and currently a State Department Certified DDM Instructor, Chuck Simpson.**
